Match Comments:

Fitchburg, Wis. - Edgewood College women's tennis claimed a 5-4 win over Concordia University Tuesday in the Lake Michigan Conference opener from McKee Farms Park. The Eagles were able to rally victory despite forfeiting two points due to injury.

The Eagles (1-2, 1-0 LMC) played without injured No. 5 singles and No. 2 doubles player Abby Krezinski and had to surrender a pair of matches to visiting Concordia (0-3, 0-1 LMC). With a 2-0 deficit to begin the match, Edgewood head coach Doanh Wang needed a big performance from a few individuals.

Sophomore Chelsea Van Hefty (DePere, Wis.) improved to 3-0 at No. 1 singles by defeating the Falcons' Renelle Hui in consecutive sets (6-1, 6-2). Van Hefty and teammate Monica Kane (Madison, Wis.) also garnered an 8-2 win at No. 2 doubles. Kathryn Wunnicke (Madison, Wis.) and Becky Lohaus added victories at the No. 2 and No. 6 singles flights, respectively. But perhaps the most dramatic point of the afternoon was won by Lauren Georgia (DePere, Wis.) at the No. 3 singles slot.

With the match even at 4-4, Georgia lost a first-set tie-breaker to Concordia's Eva Janke. Georgia rebounded with a 6-2 win in the second set and sealed the point and the match with 6-3 win over Janke in the third and final set.
